Section 3 - Hazards Identification

*** Emergency Overview ***: Contents Under Pressure. Harmful if inhaled. May affect the brain or nervous system causing dizziness, headache or nausea. Harmful if swallowed. Extremely flammable liquid and vapor. Vapors may cause flash fire or explosion.

Effects Of Overexposure - Eye Contact: Causes eye irritation.

Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.

IARC lists Ethylbenzene as a possible human carcinogen (group 2B).

May cause central nervous system disorder (e.g., narcosis involving a loss of coordination, weakness, fatigue, mental confusion, and blurred vision) and/or damage. Reports have associated repeated and prolonged occupational overexposure to solvents with permanent brain and nervous system damage. Overexposure to xylene in laboratory animals has been associated with liver abnormalities, kidney, lung, spleen, eye and blood damage as well as reproductive disorders. Effects in humans, due to chronic overexposure, have included liver, cardiac abnormalities and nervous system damage. Contains carbon black. Section 7 - Handling And Storage
