Section 3 — Hazards Identification

ROUTES OF EXPOSURE: Exposure may be by INHALATION and/or SKIN or EYE contact, depending on conditions of use. To minimize exposure, follow recommendations for proper use, ventilation, and personal protective equipment.

EFFECTS OF OVEREXPOSURE: Irritation of eves. skin and upper respiratory system. May cause nervous system depression. Extreme overexposure may result in unconsciousness and possibly death.

SIGNS AND SYMPTOMS OF OVEREXPOSURE: Headache, dizziness, nausea, and loss of coordination are indications of excessive exposure to vapors or spray mists. Redness and itching or burning sensation may indicate eve or excessive skin exposure.

Section 4 — First Aid Measures

Section 7 — Handling and Storage

HANDLING: Keep out of reach of children. Keep away from heat sparks, and open flame. Vapors will accumulate readily and may ignite explosively. During use and until all vapors are gone: Keep area ventilated-Do Not Smoke- Extinguish all flames, pilot lights, and heaters - Turn off stoves, electric tools and appliances, and any other source of ignition. Consult NFPA Code, Use approved Bonding and Grounding procedures. Contents under pressure. Do not puncture, incinerate, or expose to temperatures above 120°F.
