Section 2 - Hazards Identification

Emergency Overview: A pink paste product with a slight odor. WARNING! May cause eye, skin, nose, throat and respiratory tract irritation. Removal of this product after use or by dry sanding will generate dust and exposure to this dust may be irritating to the eyes, ears, nose and mouth. Harmful by inhalation and if swallowed. If dry-sanded, exposure to dust may result in build-up of material in eyes, ears, nose, and mouth. This product contains ethylene glycol.

Effects Of Overexposure - Eye Contact: May cause eye irritation.

Effects Of Overexposure - Skin Contact: May cause skin irritation. May cause dry skin.

Effects Of Overexposure - Inhalation: Inhalation may cause irritation to the respiratory tract (nose, mouth, mucous membranes). Inhalation of dust may cause lung damage or other adverse pulmonary and respiratory effects.

Effects Of Overexposure - Ingestion: Harmful or fatal if swallowed. If ingested, may cause vomiting, diarrhea, and depressed respiration. Ingestion may result in obstruction when material hardens. Ingestion of ethylene glycol can cause gastrointestinal irritation, nausea, vomiting, diarrhea and if ingested in sufficient quantities, death.

Effects Of Overexposure - Chronic Hazards:

The International Agency for Research on Cancer (IARC) has determined that crystalline silica in the form of quartz or cristobalite that is inhaled from occupational sources is carcinogenic to humans (Group 1- carcinogenic to humans). Refer

to IARC Monograph 68, Silica, Some Silicates and Organic Fibres (published in June 1997) in conjunction with the use of these materials. The National Toxicology Program (NTP) classifies respirable crystalline silica as "known to be a human carcinogen". Refer to the 9th Report on Carcinogens (2000). The American Conference of Governmental Industrial Hygienists (ACGIH) classifies crystalline silica, quartz, as a suspected human carcinogen (Group A2). Breathing dust containing respirable crystalline silica may not cause noticeable injury or illness even though permanent lung damage may be occurring. Inhalation of dust may have the following serious chronic health effects: Excessive inhalation of respirable dust can cause pneumoconiosis, a respiratory disease, which can result in delayed, progressive, disabling and sometimes fatal lung injury. Symptoms include cough, shortness of breath, wheezing, non-specific chest illness and reduced pulmonary function. Smoking exacerbates this disease. Individuals with pneumoconiosis are predisposed to develop tuberculosis. There is some evidence that breathing respirable crystalline silica or the disease silicosis is associated with an increased incidence of significant disease endpoints such as scleroderma (an immune system disorder manifested by fibrosis of the lungs, skin and other internal organs) and kidney disease. Studies have shown that repeated inhalation of ethylene glycol has produced adverse cardiovascular changes in laboratory animals. Ethylene glycol has been shown to cause birth defects in laboratory animals.
