### 4. First-aid measures

### 5. Fire-fighting measures

## 6. Accidental release measures

### Personal precautions, protective equipment and emergency procedures

Keep unnecessary personnel away. Keep people away from and upwind of spill/leak. Wear appropriate protective equipment and clothing during clean-up. Avoid breathing mist/vapor. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Ventilate closed spaces before entering them. ### Methods and materials for containment and cleaning up

Keep combustibles (wood, paper, oil, etc.) away from spilled material. The product is immiscible with water and will spread on the water surface. Absorb in vermiculite, dry sand or earth and place into containers. Following product recovery, flush area with water.

## 7. Handling and storage

### Precautions for safe handling
